Official Rules:

1. Registration Fee: \$150 per boat entered on or before July 2nd. \$175 per boat for those entering after July 2nd.
2. A maximum of 4 anglers may fish per boat. No other means of fishing permitted. No more than 4 rods to be fished at one time. No hand lines or umbrella rigs permitted.
3. Hours of fishing to be from 7:00 AM to 3:30 PM. Areas of fishing to be Ocean City and vicinity. Boats may not leave inlet before 6:00 AM. All boats must leave and return via Ocean City Inlet (GE Inlet).
4. Weigh-in to be held at 24-7 Bait & Tackle, All Seasons Marina, Brennan Marine, Captain Andy's Marina and FinAtics. No weigh-in after 4:00 PM.
5. Only one fish in each category per boat may be submitted for weigh-in. Only one prize in each category will be awarded to any boat. One member of each party shall accompany the fish for weigh-in.
6. Prizes to be awarded by Fishing Committee at 4:30 PM. Wonderful food and beverages (picnic style) will be served from 4:00 PM to 6:00 PM for all contestants. Award ceremony at All Season's Marina, on the Marmora side of the 34th St. Bridge.
7. In the event of a tie in any category, the winner shall be determined by flat overall length. If a winner still cannot be determined, the first fish checked in shall be the winner.
8. In the event of poor weather conditions, the alternate date will be Sunday, July 10th.
9. Postponement shall be broadcasted on Vhf Channel 68 between 6:00 and 7:00 AM the morning of the tournament. Under any conditions, **ALL ANGLERS ARE FISHING AT THEIR OWN RISK - SO BE SAFE!!** Any questions call Jon's cell phone 609-827-4786.
10. Any protest must be presented to the tournament directors by weigh-in time. Ocean City Exchange Club President or delegate shall serve as judge in such cases and his decision shall be final.
11. Any size boat shall be eligible to participate in this tournament.

Clarification - To leave by way of the GE Inlet boats must cross the GE INLET COLREGS DEMARCATION LINE when heading to the sea. To return by the way of the GE Inlet boats must cross the GE INLET COLREGS DEMARCATION LINE WHEN HEADING TO THE bAY
